Terms and Conditions

1.0 Membership

1. Membership is valid for one year from 1st April to 31st March or from the date of joining to 31st March. Upon joining or renewing, all members must pay the full annual fee according to their chosen membership category. Membership cost is contained in the online membership joining/renewal process found on the club website via ClubSpark.
2. Membership categories and costs are defined in the membership section of the club website. Family memberships are for the appropriate number of adults and a maximum of 3 juniors living at the same address. Members who have not paid renewal fees within 15 days of the due date will be deemed to have lapsed their membership and will not be entitled to use the club facilities, enter club competitions or represent the club in any competition.
3. Members details will not be shared with any third party other than ClubSpark.
4. The court access code must not be shared with non-members and will be subject to periodic change.
5. Joining and membership renewals are all online via the ClubSpark system. Members are requested to provide and/or check their details and amend if required on renewal.

7. The primary means of communication is by email. Members are requested to modify their account details if their email or mobile number changes. Club events are also publicised via social media.

Any member failing to act in accordance with these codes/policies may be challenged regarding their conduct and may be asked to leave the court or club premises. Continual refusal to abide by the rules, codes and policies may result in withdrawal of membership.**

3.0 General

- 1. The club takes no responsibility for unsupervised juniors outside of normal coaching or club playing sessions.**
- 2. The club takes no responsibility for personal items left at club premises.**
- 3. The club request that members take all their rubbish away with them and leave the Clubhouse in a tidy state.**
- 4. The Clubhouse must be left locked and secured by the last member leaving the courts.**
- 5. Only tennis must be played on the courts. Any other activity has to be agreed by the Committee.**
- 6. A winter floodlight fee is levied for any member using the floodlights. A Clubhouse key will also need to be purchased for access to floodlight controls.**
- 7. Players selected for teams are required to pay a match fee which will be collected by the Team Captain.**
- 8. Guest fee payment is the responsibility of the inviting member. The Committee reserve the right to limit the number of guest appearances by non-members.**
- 9. Only the advertised coaching provider has authorisation to deliver coaching services to club members. Any member wishing to use the courts for other coaching activity either providing or receiving coaching must seek permission from the club Committee in advance. Any members found to be in breach of this term may have their membership revoked.**
- 10. Appropriate sports clothing must be always worn (i.e. correct non-slip, non-marking footwear and tops work at all times).**
- 11. All members must assess the risk of playing in adverse weather conditions to satisfy themselves that the courts are safe for use. Any member (or guest) playing on the courts do so at their own risk.**
